Dereck Klukas medaled by finishing 2nd place and 11th place. Drew also broke the cross

country 5K school record this season with a time of 15:48.

#### **Capital Outlay Van Purchases**

The 2025 Transit Van prices have been released for Fleet Vehicles. Shawnee Mission Ford has the State Contract #5600E. The conversion of the 12 passenger to a 10 passenger must take place by the manufacturer before being delivered to the dealership while it is a non titled vehicle. The request is to purchase 2 Transit Vans since multiple suburbans we have are over 200,000 miles. These will be on the highway for activity trips to take place with up to 9 students and a driver without having a CDL.
